Although it is not required, we recommend that you test your child on or after August 31, 2021. Free testing will be available across the street from the school at the Marin City Health and Wellness Clinic. We will follow up with exact details on Monday, August 30, 2021.

Dear 8th Grade (Cohort A) Bayside Martin Luther King Jr. Academy Parents/Guardians and Staff:

The health and safety of our students and staff is our top priority. This letter is to inform you that a student or staff member in your child's classroom at Bayside Martin Luther King Jr. Academy has tested positive for COVID-19. The last date of known exposure to the classroom was August 30, 2021. Your child has been identified as a close contact of the positive person. Because everyone was masked, close contacts are eligible for modified guarantine.

**Cohort A Schedule:** Period 1 - English, Period 2- Social Studies, Period 3- Academic Workshop (Holcomb), Period 4- Academic Workshop (Scripps), Period 5- Math, Period 6- PE, Period 7- Science, Period 8- Elective

**VACCINATED:** If your child is fully vaccinated (It has been 14 days or more since their second shot) your child may continue to attend school. They should get tested for COVID-19 5 days after the exposure. Please provide proof of vaccination to your school if you have not already done so.

**NOT VACCINATED OR PARTIALLY VACCINATED:** If your child is not fully vaccinated, they may continue to attend school during the quarantine period. They may not attend any extracurricular, sports, social, or community activities including afterschool programs and child care in the 8 days after the exposure. They must remain fully masked at school and must get a COVID-19 test on Day 5 (September 4, 2021) after exposure. Free testing will be available across the street from the school at the Marin City Health and Wellness Clinic. Modified quarantine will end on Day 8 (September 7, 2021) if the test is negative.

Watch your child for symptoms of COVID-19. If your child develops symptoms of COVID-19 (cough • shortness of breath / difficulty breathing • loss of taste or smell, fever (100.4°F/38°C or higher) or chills • sore throat • diarrhea • congestion/runny nose), they must be tested for COVID-19 or evaluated by a healthcare provider. If not, they must stay at home and isolate for at least 10 days. If your child tests positive, please contact your school immediately.
