Finance Committee and Budget Study

The district budget is a plan that ties our budget with the strategic priorities and goals of the district. It addresses the challenges inherent to school finance, and helps us sustain fiscal health and integrity.

This time of year we complete our 2nd Interim Budget Report (adopted 3/14/13 and available on the Business Department link of our website) and begin studying the impact of the Governor's proposed budget on school district funding. We start by developing the budget for the following year. This is based on many factors including the adopted State Budget Act, board policy, legal compliance, ever-changing revenue and expenditure assumptions, historical trends, enrollment projections, and staffing formulas.

This year, as has been the case every year, we face a new set of challenges as we move toward adopting next school year's budget, required by June 30th. Some of these challenges are due to the new proposal for school district funding, the Local Control Funding Formula. Both state and federal budgets will impact the SMCSD budget. We are faced with a reduction of federal funding, and flat revenue streams from the state LCFF and local property taxes. It will take some time for the slow economic recovery to have a positive impact on the SMCSD budget. Additionally, we must ensure a successful transition from the consolidation of Bayside Elementary with MLK Academy in Marin City.

Meanwhile, it is important for us to talk to our stakeholders about our planned expenditures. In answer to the always present question "how is the money spent" we can provide the following information:

Our budget expenditures support our strategic priorities—a rich curriculum and program for our students, our highly qualified staff, professional development and the tools necessary for an "exceptional" learning experience for all students. Approximately 60% of our budget is spent on salaries and benefits for certificated and classified staff. The district has prioritized staffing and programs and we have managed through the fiscal crisis of the last five years with little or no reductions of staff. The recent decision to close Bayside and combine it with MLK in Marin City means there will be some staffing reductions. However, grade-level classrooms, enrichment activities and supports for students are still priorities.

Moving forward into 2013-14, our challenges include addressing the growth of Willow Creek Academy, supporting and ensuring equitable funding for all students, collaboration and community relations and long-range fiscal stability. As we prepare to open the K-8 school in Marin City, we will work to prioritize equity among the schools.

We will actively plan and project our future. How will we grow and keep pace with educational change and reforms and assure excellence and continuous improvement? How will we ensure we are culturally responsive? Our budget each year is adopted with positive certifications for three years. Our goal is to keep our eye on the future, enhance revenues if we can, and support and grow a quality education in the SMCSD school district.
